

Shareholder Communications Strategy

Approved by the Board with effect 21 October 2025

1. General

The Board of the Company aims to ensure that the shareholders are informed of all major developments affecting the Company's state of affairs.

Information is communicated to shareholders through:

- a) the Annual Report which is distributed to shareholders if they have elected to receive a printed version and is otherwise available for viewing and downloading on the Company's website and filed on SEDAR+ in Canada;
- b) the half-yearly report which is placed on the Company's website and filed on SEDAR+ in Canada;
- c) the quarterly reports which are placed on the Company's website and filed on SEDAR+ in Canada;
- d) disclosures and announcements disseminated publicly and made to the Australian Securities Exchange (ASX) copies of which are placed on the Company's website and filed on SEDAR+ in Canada;
- e) news releases are placed on the Company's website and filed on SEDAR+ in Canada;
- f) notices and explanatory memoranda of Annual General Meetings (AGM) and General Meetings (GM) copies of which are placed on the Company's website and filed on SEDAR+ in Canada;
- g) the Chair's address and the CEO/MD's address made at AGMs and GMs, copies of which are placed on the Company's website;
- h) the Company's website on which the Company posts all announcements which it makes to the ASX; and
- i) the auditor's lead engagement partner being present at the AGM to answer questions from shareholders about the conduct of the audit and the preparation and content of the auditor's report.

Links are made available to the Company's website on which all information provided to the ASX is immediately posted.

Shareholders who are unable to attend the AGM or a GM may submit questions and comments before the meeting to the Company or to the auditor (in the case of the AGM).

At least 3 historical years of the Company's Annual Report is provided on the Company's website.

Shareholders queries should be referred to the Company Secretary in the first instance.
